• OBJECTIVES AND INVESTMENT POLICY

We aim to provide you with **long term growth of your capital**.

We mainly invest in **shares of European companies and bonds (loans) issued by both European states and companies**, paying either fixed or variable interest. All are dealt in on a stock exchange.

We take investment decisions on the basis of our **anticipations** concerning the **economic condition** across Europe. We conduct **in-depth analyses** of economies, sectors and companies, which provide us with growth prospects. We then invest in those shares and bonds which offer the **highest growth potential**. Repartition between shares and bonds is constantly adjusted to take the impacts of changing economic situations into account.

This share class does not distribute any income to you.

You can buy and sell shares of this class every bank business day in Luxembourg.

This share class is listed and may be purchased and sold on **Borsa Italiana**.

Your **first investment** must amount at least **one share**.

• CHARGES

Underperformance from previous quarters first need to be recovered. In the Fund's last financial year the performance fee charged was 0.29% of the Fund.	

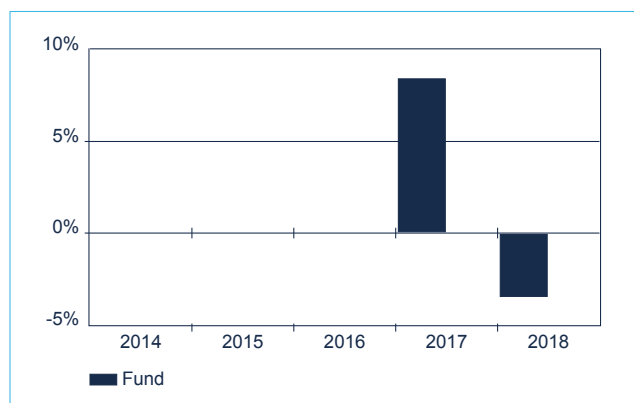
The **entry** and **exit charges** shown are **maximum** figures. In some cases you may pay less - you can find this out from your personal investment adviser or distributor.
