• OBJECTIVES AND INVESTMENT POLICY

We aim to achieve **growth in your capital** over medium to long term (3 to 5 years).

We invest in **other funds** which themselves invest in short term bonds (loans) (**money market instruments**) and other **bonds** worldwide. Funds are selected on the basis of their past track record and the ability of their manager to achieve consistently high returns. We may also invest directly in money market instruments and bonds.

With the purpose of investing or protecting your investment, we may use financial contracts. Given their characteristics, these instruments may have a significant influence on the return of the Fund.

This share class does not distribute any income to you.

You may buy and sell shares of this class every bank business day in Luxembourg, provided you qualify as an **institutional investor**.

Your **first investment** must be equal or amount to **more than 10,000.00 euros**.

• RISK AND REWARD PROFILE



The above indicator reflects the historical level of risk and reward of this share class over the last 5 years.
